From the North:

Take Rte 7 South to Middlebury. Turn right onto Rte 125 & 30 South. Follow the signs for Rte 30 South. In 4.5 miles (in Cornwall) bear right onto Rte 74 West. In 2.5 miles look for Hand-In-Paw on the left.

From the South:

Take Rte 7 North to Middlebury. Turn left onto Rte 125 & 30 South. Continue same as from North from this point on.

Alternate Routes from South:

Take Rte 30 to Cornwall and turn left onto Rte 74 West. Go 2.5 miles to Hand-In-Paw on the left. OR take Rte 22A North to Shoreham. Turn right onto Rte 74East. Go 5 miles to Hand-In-Paw on the right
